### SUBDIVISION STREET LIGHTS

### RICHLAND TWO GOLD CARDS

Senior citizens in Richland Two can enjoy athletic events, shows and more by using their Richland Two Gold Card! Effective immediately, Gold Cards will be issued everyday from 8 a.m. to 4:30 p.m. at the District Office, R2i2 located at 763 Fashion Drive, Columbia, SC 29229.

Gold Cards are offered to anyone age 60 or older living in the district and to all Richland Two retirees. Proof of residence will be requested. Those interested in obtaining

Proof of residence will be requested. Those interested in obtaining a card can come in to register and receive a card. Cards have no expiration date, so current card holders do not have to renew their cards.

Gold cardholders enjoy:

- $\checkmark$  A discount on adult education classes;
- Free admission to concerts, plays and other events sponsored by District schools;
- ✓ Free admission to all regular season athletic events (playoff games and tournaments are not included);
- ✓ Lunch in any school cafeteria, any day, for the regular adult price of \$3.70

### SC REAL ID

**Beginning October 1, 2020**, your South Carolina driver's license or identification card must have a gold star to show it's a **REAL ID** in order to use it as your identification to board a domestic, commercial flight, enter a secure federal building, or visit a military installation.

You **do not need** a **REAL ID** driver's license or identification card to do any of the following:

- $\checkmark$  Drive
  - ✓ Drive
    ✓ Vote
  - ✓ Vote
  - ✓ Apply for or receive federal benefits for which you're entitled (Veterans Affairs, Social Security Administration, etc.)
  - Enter a federal facility that does not require an ID (i.e. a post office)
  - Access a hospital or receive life-saving services
  - Participate in law enforcement proceedings or investigations (serve on a federal jury, testify in federal court, etc.)
  - ✓ If you have a valid US Passport, military ID, or another federal identification that's accepted to <u>pass</u> <u>airport security</u>, you may use this instead of changing your SC license or ID to a REAL ID.

#### **DOCUMENTS NEEDED**

- ✓ Proof of Identity Examples: Government-issued birth certificate or unexpired US Passport
- ✓ Proof of Social Security Number
- ✓ Two proofs of Current, Physical SC Address
- ✓ Proof of all Legal Name Changes

If you are a veteran who has honorably served in the U.S. Armed Services bring your Discharge Certificate DD-214 to add the Veteran's designation to your license or ID Card.
