#### MARCH ON WASHINGTON

On August 28, 1963, the Civil Rights Movement reached its climax when 250.000 people marched on Washington, D.C. Marchers demanded the government pass laws to give



African Americans equal rights. Many people spoke and musicians performed at the march. The most famous event that day was Reverend Dr. Martin Luther King, Jr. giving his "I Have a Dream" speech. Broadcast live on TV and radio, the speech touched and inspired millions of Americans. The next year, the Civil Rights Act was made into law.

**HOSPITALIZATIONS:** Health officials say the numbers show the virus is spreading more rapidly in the community. The state average of hospital capacity is at 80%. The threat of hospitals reaching capacity is being reviewed statewide.
