BULK ITEM COLLECTION, PLEASE CALL 805-576-2440.

Items that qualify includes refrigerators, stoves, microwaves, washing machines, dryers, dishwashers, (doors must be removed from appliances), hot water heaters, metal grills (no propane tanks), push lawnmowers (no gas or oil), furniture and mattresses.

You must call for an appointment to have items picked up from curb side. Please DO NOT put iems on the curb until you have an appointment date for pick-up.

If items are not picked up as scheduled, please call 803-576-2440 for a friendly reminder. Thank you for your cooperation.

YARD WASTE COLLECTION. Yard waste is collected weekly and should be at curbside by 7:00 a.m. What will be collected? Grass clippings, loose leaves, sticks/brushes (NO LONGER THAN 4 FEET) generated from routine landscaping (NO stumps or large limbs), bagged and containerized vard debris.


