The question is, why have so many of you not paid your dues?

Some of us are working hard to keep Newcastle "a safe and beautiful place to call home." Too many communities around us are deteriorating and experiencing increased crime rates. Don't you understand we are a hardworking, proud community?

You can see that pride every Saturday morning when the Adopt a Highway crew led by Mr. Sammy Parks is on Warner Drive picking up trash. You can see it when you come through the beautiful entryways of our subdivision, and you can certainly see it if you attend the events in our community. We are a strong Community!
